

**RESOLUTION NO. R2015-6**

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WILDWOOD, FLORIDA ESTABLISHING A CITIZEN'S ADVISORY TASK FORCE TO ADVISE ON COMMUNITY IMPROVEMENTS FUNDED BY THE COMMUNITY DEVELOPMENT BLOCK GRANT AND OTHER STATE AND FEDERAL PROGRAMS, AS APPLICABLE; APPOINTING MEMBERS TO IT; PROVIDING FOR INDEFINITE TERMS; REPEALING ALL RESOLUTIONS IN CONFLICT HEREWITH AND RECITING AN EFFECTIVE DATE.

**WHEREAS**, community improvements that are funded by the Community Development Block Grant ("CDBG") and other state and federal funding programs will benefit the City of Wildwood; and

**WHEREAS**, the City will also benefit from a citizen advisory task force during the grant development and implementation process.

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF WILDWOOD, FLORIDA, that:**

**SECTION 1.** The City Commission of the City of Wildwood establishes the Citizen Advisory Task Force to provide advisory input on the CDBG program and other state and federally funded projects.

**SECTION 2.** The Citizen Advisory Task Force shall be composed of at least five (5) members, all of which must reside in the City of Wildwood. Only one of the members may be a City employee; none of the members shall be elected officials of the City of Wildwood; and at least 51% (3) of the members must have low to moderate incomes as per HUD income limits. The Citizens Advisory Task Force members are hereby appointed as shown on Attachment "A" to this resolution.

**SECTION 3.** Members of the Citizen Advisory Task Force shall serve an indefinite term, but may resign or be removed by the City Commission at any time for any reason.

**SECTION 4. REPEAL.** All resolutions or parts of resolutions in conflict herewith are repealed to the extent of such conflict.



SEVERABILITY.** If any section, subsection, sentence, clause or phrase of this resolution is for any reason held invalid or unconstitutional by the decision of any court or regulatory body of competent jurisdiction, such decision shall not affect the validity of the remaining portions hereof.


**SECTION 6. EFFECTIVE DATE.** This Resolution shall take effect immediately upon its passage.


