





Rollback Rate



The abundant growth in Wildwood is powering reduced property taxes.

FY24 will be the sixth straight fiscal year that the City has reduced the millage rate, a welcome trend for property owners.

Ad Valorem Taxes based on a \$300,000 assessed Home in Sumter County with 2 Homestead Exemptions

Example:

Your home's assessed value is \$300,000 and you receive two homestead exemptions totaling \$50,000

This brings your home's taxable value down to \$250,000

Wildwood's millage rate of 2.8287 is applied for a total tax amount of \$707.18

The rollback rate is the rate that generates the same amount of tax dollars as the previous year

When comparing a property of a similar size in Wildwood to a comparable city with similar services, our taxes are lower
