#### WILDWOOD PREPARES FISCAL YEAR 2024 BUDGET

Budget season is here, and city leaders have been hard at work crunching numbers and analyzing projected costs and revenues associated with providing essential and expected services for Wildwood's rapidly growing population.

Wildwood takes this work very seriously. For five years in a row, the city has been named a Distinguished Budget Award winner by the Government Finance Officers Association of the United States and Canada (GFOA), and looks to keep the streak going.

What goes into preparing the city's budget?

It's a monthslong process that involves every department and a review of what is and is not working, based on strategic goals set the year prior. Department heads submit a list of requests, including both equipment and new positions, along with justifications for each item.

Some of the requested equipment this year includes additional and replacement police cars and work trucks for road and utilities crews, for example.

The city manager and his team scrutinize the requests and ask, "Is this really needed? How does it benefit the citizens? Is it a prudent use of taxpayer funds? Can we serve our residents without it?"

Management also looks at revenues and analyzes whether what is coming in, via ad valorem taxes, utility fees, intergovernmental revenues, and other sources, is adequate to cover the costs of all the services provided by the city. If not, adjustments need to be calculated based on projections for the coming year.

Capital projects and associated costs are considered to ensure the city's infrastructure can meet the needs of its people. Two projects currently under design are a new wastewater treatment facility and a new outreach and recreation center. What will it cost to build these projects, and how will the city pay for them?

Concurrently, city leaders review Wildwood's five-year strategic plan to assess progress toward each strategic goal. Have key metrics been met? If not, why not, and what is needed to get back on track and ensure the city is moving forward in a purposeful, thoughtful, and strategic manner?

Human resources are evaluated along with capital resources. Does the city have enough employees? Are they compensated fairly for their work? What adjustments are needed to recruit and retain a high-performing, customer-service-oriented team that takes pride in the city and its people?



Wildwood recently contracted with a consulting firm to conduct a salary and classification study to assess job titles, pay, and benefits. Those study results and recommendations are being considered as part of the current budgeting process.

Once management has analyzed all the data and answered these questions, it prepares a draft budget to present to city commissioners for review and discussion. Workshops are scheduled over the summer to allow enough time for questions, answers, and additional research and analysis.

In late July, the commission sets a tentative millage rate for ad valorum taxes as part of the budget development. This year, the commission agreed on the rollback rate of 2.8287, a tax decrease of approximately 5.7 percent. This rate provides the same ad valorem revenue, adjusted to current-year dollars, as the year before. Because the value of taxable property is increasing, the millage rate can be decreased.

During August, the commission will have another budget workshop in addition to its regularly scheduled meetings, followed by two public hearings in September to gather input from citizens on the budget.

Finally, the commission will vote on a final budget to take effect October 1, the beginning of the new fiscal year.

All commission meetings, workshops, and hearings are open to the public, and citizens are encouraged to attend and participate in the process. Agendas and supporting documents are posted on the city's website, wildwood-fl.gov, (click on the Agenda icon) at least 72 hours before each meeting.

Wildwood's current, award-winning budget can be found at wildwood-fl.gov/finance, where the new budget will be added once it is adopted.

#### WILDWOOD POLICE DEPARTMENT TO HOST FIRST FISHING TOURNAMENT

Wildwood PD will hold its first inshore fishing tournament for veterans and first responders on Saturday, August 12, 2023, at Crump's Landing in Homosassa.


The tournament starts at daylight with weigh-in at 5:00 p.m., followed by the presentation of cash awards and prizes.

A captain's check-in meeting will be held the night before, Friday, August 11, 2023, at 6:00 p.m., or the morning of the event at 6:30 a.m.

Registration closes August 1, 2023, so do not delay.

The fee is \$50 per angler, with proceeds going to Combat Veterans to Careers, a civilian 501 (c) (3) tax-exempt, non-profit organization in Wildwood.

# NEW DOWNTOWN AND DASHBOARD WEBSITES

Wildwood has launched two new websites to provide additional information about the city as it grows.

The first, data.wildwood-fl.gov, is an interactive dashboard that displays statistical information grouped into eight major categories: population, households and families, housing, education, transportation, poverty, employment and income, and healthcare.

"Measurement is the first step to improvement," said City Manager Jason McHugh. "By tracking key metrics over time, we can identify trends and make adjustments that help guide those progressions in the right direction."

Clicking the View All Data button on each main category tile expands the group to reveal details, including comparative data for prior years and/or other cities and regions.


"How does Wildwood stack up? This is what our citizens and prospective new residents are asking," said Commissioner Joe Elliott. "This dashboard will only get better as it is used and improved by individuals and organizations who have a role in Wildwood. The first step in correcting a problem is recognizing it. This effort is indeed the beginning of a new approach."

The second new site, wildwooddowntown.com, is a multimedia hub for downtown redevelopment information. Photos, videos, renderings, and words all help tell the story of Wildwood's origin, history, present, and future, focusing on the city's core.


"With downtown redevelopment underway, we wanted to provide citizens with a dedicated, centralized location for both updates as well as relevant plans, reports, and images," explained McHugh.

"We also wanted to honor and showcase the city's evolution and history," he continued. "Many of our residents have deep roots here. It is important we remember and respect their families' heritage and contributions as we all shape Wildwood's future."

Both new sites can be accessed from wildwood-fl.gov through the Community menu at the top of the page, and are considered works in progress, with new information added as it is available.

# HOW DOES CODE COMPLIANCE WORK IN WILDWOOD?

Florida Statutes Chapter 162 provides the framework for municipal code enforcement to "promote, protect, and improve the health, safety, and welfare of the citizens."

Wildwood's code compliance department oversees proactive patrols, inspections, and documentation of violations and responds to complaints made on the record by other individuals (state law does not permit enforcement action on anonymous complaints).

City staff educates residents on land development regulations, ordinances, and property maintenance codes when violations may exist and offer resources and other information that may be helpful to the owner in helping to bring properties into compliance.

When properties remain uncompliant despite education and outreach, cases are brought before Wildwood's special magistrate, who hears and rules on the alleged violations. State law gives the special magistrate "authority to impose administrative fines and other noncriminal penalties to provide an equitable, expeditious, effective, and inexpensive method of enforcing any codes and ordinances in force in counties and municipalities, where a pending or repeated violation continues to exist."

Examples of common violations:

- Junk Cars
- Overgrown Lots
- Trash
- Dilapidated Homes
- Illegal Signs
- Junk/Debris
- Semi-Trucks
- Blight





Wildwood's proactive approach to code compliance helps property owners avoid potential violations that may occur from the progression of existing conditions and helps owners avoid potential hearings and any subsequential penalties when violations already exist.

Staff recognizes that owners sometimes face extraordinary personal or financial stressors that contribute additional challenges to maintaining their properties and are knowledgeable about some of the local resources available.

The photos at right show before-and-after examples of violations that were corrected with the knowledge and resources provided by the city.

Code compliance staff helps residents keep their properties safe, preserve property values, and maintain positive relationships in their neighborhoods. For more information, including a library of fact sheets on specific code topics, visit www.wildwood-fl.gov/code-enforcement.

Residents of The Villages® and other planned developments within the City of Wildwood should be aware of any additional rules and regulations pursuant to their respective deed restrictions, homeowners' associations, and/or district government.


