### ITEMS REQUIRED AT THE TIME OF APPLICATION

- A diagram and description of the outdoor area to be designated as available to patrons' dogs, including dimensions of the designated area (should be accurate and to scale, but need not be prepared by a licensed design professional), which should include the following:
    - A depiction of the number and placement of tables, chairs, and restaurant equipment, if any;
    - The entry-ways and exits to the designated outdoor area (which demonstrate ingress / egress without need to pass through the main restaurant);
    - The boundaries of the designated area and of other areas of outdoor dining not available for patrons dogs;
    - Any fences or other barriers;
    - Surrounding property lines and public rights-of-way, including sidewalks and common pathways; and
    - Other such information reasonably required by the City.
  - A description of the days of the week and hours of operation that patron's dogs will be permitted in the designated outdoor area.
- There is no fee for this permit, but an application is required for each Dog Friendly Dining site is required. This permit is non-transferrable to a new location or new owner at the same location. Upon sale, change of ownership, or change of location, a new application is required.
