FENDER MARINE CONSTRUCTION, INC. BID NOTES

- 1. Fender Marine Construction did not identify any subcontractors with the bid package but it was determiend through coordination with representative Tim Abbott that an asphalt contractor will be brought on.
- 2. The boat dock bid alternate was confirmed to be included in the bid package through coordination with Fender Marine Construction. However, the boat dock was not separated out as a bid alternate item as requested in the bid forms. Instead, the cost of the boat dock improvements were lumped together with the pier improvement line items. Therefore, the individual costs for the pier/boat dock improvements are not discernable from the information provided.
- 3. Fender Marine Construction submitted all required documents with the bid package.
- 4. Through coordination with Fender Marine Construction, costs for compaction testing, solid waste disposal, and construction fencing/barricades were conservatively assumed as part of the bid.
- 5. Fender Marine Construction was the sole bidder for this project.
- 6. The provided previous project reference contacts were unresponsive when asked to provide feedback on Fender Marine Construction. This may due, in part, to the short bid review turnaround time on a Holiday week.
- 7. Fender Marine Construction's prior work experience in boardwalks, docks, and pier construction, checked as part of this bid review, demonstrates a proficiency in decking repair and handrail installation.
- 8. Fender Marine Construction confirmed availability to begin work in December, if selected for award by the City of Wildwood.

CPH FINAL RECOMMENDATION

CPH recommends Fender Marine Construction, Inc. for the award of the Lake Deaton Park Pier Decking Renovation project. As the only bidder for this project, Fender Marine Construction, Inc. is the lowest bidder by default. However, the Fender Marine Construction team has proven responsive and responsible through the bidding process.
